**A report must be filed after receipt of contributions or loans received from a single source totaling:**

- More than \$500 to candidates for House of Representatives
- More than \$400 to candidates for District Court Judge
- More than \$1,000 to candidates for Secretary of State and State Auditor
- More than \$1,250 to candidates for Attorney General
- More than \$2,000 to candidates for Governor, Supreme or Appeals court
- More than \$1,000 to political committees and political funds

From October 21 to November 3, 2014

**After receiving the contributions or loans, a report must be filed with the Campaign Finance and Public Disclosure Board:**

- electronically within 24 hours using the Board's Campaign Finance Reporter software or the online tool on the Board's website at [www.cfboard.state.mn.us](http://www.cfboard.state.mn.us)

OR

- in person by the end of the next business day using this form or a document including the same information.

**Additional disclosure:**

- All contributions and loans on this report must be included on the pre-general *Report of Receipts and Expenditures* and the yearend *Report of Receipts and Expenditures*.
