INSTRUCTIONS

This affidavit of contributions must be completed and filed by the candidate or the treasurer of a principal campaign committee to establish eligibility for receipt of public subsidies in the 2014 general election.

- In-kind contributions may not be counted towards the amount required to file an Affidavit of Contributions.
- Anonymous contributions may not be counted towards the amount of contributions received to file an Affidavit of Contributions.
- A contribution may be counted towards the amount required to file an Affidavit of Contributions only if the committee has recorded the name and address of the contributor.
- This affidavit must be signed by the candidate or treasurer, dated, and notarized.
- All information on this form is public.
- Please retain a copy of this affidavit for your records.
