Minnesota's Campaign Finance and Public Disclosure Act, passed in 1974, provides the public with information about public officials to reassure the public that officials are not profiting personally from their roles as decision-makers.

Public officials are required to disclose their personal financial interests, potential conflicts of interest, and representation of clients before state agencies. Lobbyists are required to disclose lobbying disbursements to influence the official actions of public officials. Reports and statements filed under the Act are available for public inspection at the Campaign Finance & Public Disclosure Board office.
