I DEFINITIONS

A. Who is a Lobbyist?

- Any individual who is engaged for pay or other consideration or authorized by another individual or association to spend money and who spends more than five hours in any month or more than \$250 in any year (not including travel expenses and membership dues), for the purpose of attempting to influence legislative or administrative action by communicating with or urging others to communicate with public officials. For purposes of this rule, administrative action means making rules or regulations or cases of rate-setting, power plant and powerline siting and granting of certificates of need (Ch. 116H).
- Any individual who spends more than \$250 in any year (not including travel expenses and membership dues) for the purpose of attempting to influence legislative or administrative action by communicating with or urging others to communicate with public officials.

B. What Is Lobbying?

- Attempting to influence legislative or administrative actions by communicating with public officials or urging others to communicate with public officials.
- "Administrative action" means an action by any official, board, commission or agency of the executive branch (does not include metropolitan agencies) to adopt, amend, or repeal a rule or to adjudicate a contested case pursuant to Chapter 15.
- "Administrative action" does not include the application or administration of an adopted rule, except in cases of rate setting, power plant and powerline siting and granting of certificates of need under Chapter 116H.
