ETHICAL PRACTICES BOARD ISSUES REPORT
ON LOBBYING DISBURSEMENTS FOR 1981

Lobbying disbursements during 1981 disclosed by 989 lobbyists for 766 associations and individuals totaled ~~\$921,443~~, according to reports filed with the Ethical Practices Board. ^{\$930,132}

Lobbyists filed a total of 5,960 quarterly reports for 1981 and disclosed that 343 associations and individuals had no disbursements for lobbying purposes (45% of the associations and individuals for whom lobbyists are registered).

Included in the Board's summary are lobbyists representing 183 associations and individuals who reported lobbying disbursements of \$585,330 (64% of total lobbying disbursements); lobbying subjects in this group include business and trade associations, businesses, chambers of commerce, petroleum and natural gas, transportation, and public utilities.

A total of 63 citizen groups reported lobbying disbursements of \$84,423 (9% of total lobbying disbursements in 1981).

Other 1981 lobbying disbursements of \$251,690 (27% of total disbursements) are reported by lobbyists for 177 associations and individuals whose lobbying subjects include health, education, agriculture and environment, banks, insurance, government, labor and public employees, and professional associations.

In 1980 total lobbying disbursements were \$572,638, reported by lobbyists for 379 associations and individuals (53% of the 715 associations and individuals represented by lobbyists); in 1979, lobbyists for 422 associations and individuals reported total disbursements of \$461,343 for lobbying purposes (57% of the 738 associations and individuals represented by lobbyists).

Lobbying disbursements for the ten associations reporting the highest expenditures in 1981 totaled \$346,953 (37% of lobbying disbursements in 1981).

Minnesota's Ethics in Government Act (Minn. Stat. Ch. 10A) requires lobbyists to report to the Ethical Practices Board disbursements for lobbying purposes including

(MORE)

a gift, loan, honorarium, entertainment, food or beverage, travel or lodging of \$20 or more to a public official; preparing and distributing lobbying materials; media advertising; telephone, telegraph, and postage; fees and allowances; entertainment, food and beverage, travel, and lodging. All lobbyist reports are available for public inspection at the Board office.

The Board has prepared a summary of lobbying disbursements during 1981, in which one regular legislative session and three special legislative sessions were held. Copies of the Lobbyist Disbursement Summary 1981 are available at the Board office, 41 State Office Building, St. Paul, Minnesota.

According to Minnesota Public Disclosure Law, Minn. Stat. 10A. (1980), "public official" means state legislators; constitutional officers, of the executive branch and their chief deputies; commissioners, deputy or assistant commissioners of state departments designed in Minn. Stat. 15.01; solicitor general, assistant or special assistant attorney general; members, chief and deputy chief administrative officers of boards and commissions with rulemaking authority; certain legislative employees; complete list is available from the State Ethical Practices Board.

ORIGINAL SOURCE OF FUNDS (to individuals or associations represented).....7-9

Minn. Stat. 10A. (1980) states "each original source of funds in excess of \$500 in any year used for the purpose of lobbying shall be reported". The list includes the name of the individual or association represented and the name of the payer of funds in excess of \$500.

TOTAL DISBURSEMENTS (by individuals and associations).....10-35

Reported herein are name of the individual or association represented; name of the registered lobbyist, indication of receipt of over \$500 by the lobbyist including salary, expenses, and reimbursement; and total disbursements for lobbying purposes.

Note

Information disclosed on Lobbyist Registration Form: name and address of the registrant, name of the individual or association (*including officers and directors*) represented, general description of subjects on which registrant expects to lobby.

All registration forms and reports filed in accordance with Minnesota Public Disclosure Law are available for public inspection at the office of the State Ethical Practices Board, 41 State Office Building, St. Paul, Minnesota 55155.

EDITOR'S NOTE: Associations or individuals represented appear in capital letters; authorized lobbyists appear in italics.

KEY: * - Terminated; + - Association reports over \$500 paid for salary, expenses, or fees for lobbying purposes in 1981. Total disbursements are rounded off to the nearest dollar.

Who is a Lobbyist?

- Individual who is engaged for pay or other consideration or authorized by another individual or association to spend money and who spends more than five hours in any month or more than \$250 in any year (*not including travel expenses and membership dues*) for the purpose of attempting to influence legislative or administrative action by communicating with or urging others to communicate with public officials. For purposes of this rule, administrative action means making rules or regulations or cases of rate-setting, power plant and powerline siting and granting of certificates of need (Minnesota Statutes Chapter 116H).
- Any individual who spends more than \$250 in any year (*not including travel expenses and membership dues*) for the purpose of attempting to influence legislative or administrative action by communicating with or urging others to communicate with public officials.
- Any individual who merely communicates with a public official to obtain information or request an interpretation of a law, rule or agency action is not a "lobbyist."

What is Lobbying?

Lobbying is defined as attempting to influence legislative or administrative action by communicating with public officials or urging others to communicate with public officials.

- "Administrative action" means an action by any official, board, commission or agency of the executive branch (*does not include metropolitan agencies*) to adopt, amend, or repeal a rule. "Administrative action" does not include the application or administration of an adopted rule, except in cases of rate setting, power plant and powerline siting, and granting of certificates of need under Minnesota Statutes Chapter 116H.
- "Legislative action" means any action or nonaction with regard to any bill, resolution, amendment, nomination, appointment, report, or any other matter which may be the subject of action by either house of the legislature, committee, subcommittee, or commission of the legislature. "Legislative action" also means an attempt to influence a gubernatorial approval or veto of any bill, or an attempt to influence the governor or any public official about development of a proposal for introduction in the legislature.

What must Lobbyists report?

Yearly lobbyists are required to file quarterly reports with the Ethical Practices Board. During calendar year 1981, 989 lobbyists filed approximately 1490 reports disclosing expenditures totalling ~~\$910,917.52~~ **\$930,132.47**
Unless separate reports are filed, all disbursements are considered to be for legislative lobbying.

DISBURSEMENTS (reporting categories)

- **Preparing and distributing lobbying materials**
The cost of research and writing of reports from which data is subsequently used for lobbying materials is not reportable.
The cost of preparation, publication, and distribution of newsletters or other publications includes pro-rata office expenses and compensation paid to an employee. However, only the cost of that portion of the newsletter or publication which is lobbying material need be reported.
- **Media Advertising**
Only the cost of media including but not limited to billboards, newspapers, radio, and television time which advocate a particular position is reportable.
- **Telegraph and telephone**
- **Postage**
- **Fees, salaries, and allowances**
Includes consultant fees for lobbying purposes as well as expenses incurred in providing those services. Includes compensation for clerical expense incurred for providing lobbying materials or organizing communication with public officials or in urging others to communicate with public officials.
This category does not include compensation paid to a lobbyist for services as a lobbyist on behalf of the employer.
- **Entertainment**
Includes cost of entertainment provided for a lobbying purpose to public officials as well as the cost of entertainment for the lobbyist, the employer, or employee of the lobbyist when in the company of the public official for whom the lobbyist has paid the cost of the entertainment.
- **Food and beverage, travel, and lodging**
Includes the cost of food, beverages, travel, and lodging provided by a lobbyist, the employer, or employee of a lobbyist at meetings, banquets, or similar functions for a lobbying purpose.
Includes the costs of food, beverages, travel and lodging provided by a lobbyist, the employer, or employee of a lobbyist at meetings or conferences for the purpose of urging others to communicate with public officials.
Includes the cost of food, beverages, travel, and lodging for paid expert witness if not registered as a lobbyist.
Includes the cost of travel and lodging of a lobbyist for the purpose of lobbying *except* those incurred to enable the lobbyist to attend a meeting of or to appear before a committee of the legislature, a state board, commission, or agency.

DISBURSEMENTS (to public officials)

Additional information which lobbyists must disclose includes any gift; loan; honorarium; entertainment; food and beverage, travel, and lodging equal in value to \$20 or more to a public official from a lobbyist, a lobbyist's employer, or an employee of a lobbyist.
