ETHICAL PRACTICES BOARD ISSUES REPORT ON LOBBYING DISBURSEMENTS

FOR JULY, 1988 THROUGH JUNE, 1989

Lobbying disbursements disclosed by 1,470 lobbyists for 1,115 associations and individuals totaled \$2,367,023 according to reports filed with the Ethical Practices Board.

Lobbyists have filed a total of 8,687 quarterly reports for the twelve month period and disclosed that 646 associations and individuals reported disbursements for lobbying purposes (58% of the associations and individuals for whom lobbyists are registered).

Included in the Board's summary report are disbursements during the first year of the 1988-1989 legislative session. Lobbyists representing 446 associations reported lobbying disbursements of \$1,508,666 (64% of total lobbying disbursements); lobbying subjects in this group include Business Related Associations, Businesses, Chambers of Commerce, Petroleum and Natural Gas, Transportation and Public Utilities.

A total of 197 citizen groups and individuals reported lobbying disbursements of \$153,432 (7% of total lobbying disbursements in 1988-1989).

Other 1988-1989 lobbying disbursements of \$704,925 (30% of total disbursements are reported by lobbyists for 472 associations whose lobbying subjects include Health, Education, Agriculture/Environment, Banks, Insurance, Government, Labor/Employee Relations and Legal.

For July, 1987, through June, 1988, the second year of the 1987-1988 legislative session, 1,390 lobbyists for 1,029 associations and individuals

reported total lobbying disbursements of \$2,373,228 (59% of the associations and individuals for whom lobbyists were registered).

Total lobbying disbursements of \$1,879,897 for January through June, 1987, the first year of the 1987-1988 Legislative session, were reported by 1,162 lobbyists for 589 associations and individuals (63% of the 933 associations and individuals represented by lobbyists).

Lobbying disbursements for legislative lobbying in 1988-1989 totaled \$2,266,284 (96% of total lobbying disbursements), compared with \$1,509,263 July, 1987-June, 1988, (64%) and \$1,697,425 in January - June, 1987 (90%). Administrative lobbying disbursements in 1988-1989 totaled \$100,738 (4% of total lobbying disbursements), compared with \$863,965 in July, 1987 - June, 1988 (36%), and and \$182,471 in January - June, 1987 (10%).

Minnesota's Ethics in Government Act (Minn. Stat. 10A) requires lobbyists to report to the Ethical Practices Board disbursements for lobbying purposes including a gift, loan, honorarium, entertainment, food or beverage, travel and lodging of \$50 or more to a public official; preparing and distributing lobbying materials, media advertising, telephone and telegraph, postage, fees and allowances, entertainment, food and beverage, travel and lodging. Lobbyists are not required to disclose their salaries or their political contributions. All lobbyist reports are available for public inspection at the Board office, 625 North Robert Street, St Paul.

The Board has prepared a summary of lobbying disbursements for July, 1988, through June, 1989. Included are listings of individuals or associations that contributed over \$500 to associations for lobbying purposes and public officials who received gifts, honorariums or other benefits of \$50 or more disclosed in reports filed by lobbyists for 1988-1989. A copy of the summary is available for viewing at the Board office.



About This Summary

Information in this summary is based on reports filed by lobbyists registered with the Ethical Practices Board. Neither verified nor audited, these reports are available for public inspection at the Board office. No information from filed reports or statements may be sold or utilized by any individual or association for any commercial purpose. Information compiled as of August 30, 1989.

"Original source of funds" to associations or individuals represented by a lobbyist - Minn. Stat. Ch. 10A requires that "each original source of funds in excess of \$500 in any year used for the purpose of lobbying shall be reported". List includes the name of the association or individual receiving the funds and the name of the association or individual paying the funds.

"Disbursements" to public officials - Lobbyists must disclose any gift, loan, honorarium, entertainment, food and beverage, travel, and lodging equal in value to \$50 or more to a public official from the lobbyist, the lobbyist's employer, or an employee of the lobbyist. "Public official" means state legislators; constitutional officers of the executive branch and their chief deputies; commissioners, deputy or assistant commissioners of state departments designated in Minn. Stat. §15.01; solicitor general, assistant and special assistant attorneys general; members, chief and deputy chief administrative officers of boards and commissions with rulemaking authority; certain legislative employees; complete list of "public official" designees is available from the Ethical Practices Board office.

"Total disbursements" by association or individual - This summary includes total disbursements for lobbying purposes by associations or individuals represented by registered lobbyists; "*" indicates payment of more than \$500 to a lobbyist for lobbying purposes.

Who is a Lobbyist? _____

- . Any individual who is engaged for pay or other consideration or authorized by another individual or association to spend money and who spends more than five hours in any month or more than \$250 in any year (not including travel expenses and membership dues) for the purpose of attempting to influence legislative or administrative action by communicating with or urging others to communicate with public officials.
- . Any individual who spends more than \$250 in any year (not including travel expenses and membership dues) for the purpose of attempting to influence legislative or administrative action by communicating with or urging others to communicate with public officials.
- . Any individual who merely communicates with a public official to obtain information or request an interpretation of a law, rule or agency action is not a "lobbyist".

What is Lobbying? _____

Lobbying is defined as attempting to influence legislative or administrative action by communicating with public officials or urging others to communicate with public officials.

- . "**Administrative action**" means an action by any official, board, commission or agency of the executive branch (does not include metropolitan agencies) to adopt, amend, or repeal a rule. "Administrative action" does not include the application or administration of an adopted rule, except in cases of rate setting, power plant and powerline siting, and granting of certificates of need under Minnesota Statutes Chapter 116J.
- . "**Legislative action**" means any action or nonaction with regard to any bill, resolution, amendment, nomination, appointment, report, or any other matter which may be the subject of action by either house of the legislature, committee, subcommittee, or commission of the legislature. "Legislative action" also means an attempt to influence a gubernatorial approval or veto of any bill, or an attempt to influence the governor or any public official about development of a proposal for introduction in the legislature.

About Lobbyist Registration _____

A lobbyist must complete and file with the Ethical Practices Board a Lobbyist Registration on behalf of each association or individual whom the lobbyist represents. Information disclosed on Lobbyist Registration Form: name and address of the registrant, name of the association (including officers and directors) or individual represented, and general description of subjects on which registrant expects to lobby.

All lobbyist registrations and lobbyist quarterly reports filed under the Ethics in Government Act, Minnesota Statutes, Chapter 10A, are available for public inspection at the Board office, 625 North Robert Street, St. Paul, MN 55101-2520.

What must Lobbyists report? _____

Each year lobbyists are required to file quarterly reports with the Ethical Practices Board. For description of "Disbursement Categories", see page 23. From July, 1988 through June, 1989, 1,470 lobbyists filed approximately 8,687 reports for 1,115 associations or individuals, disclosing lobbying disbursements of \$2,367,023.

ORIGINAL SOURCE OF FUNDS (for lobbying purposes)

Lobbyists must disclose the names of individuals or associations that pay over \$500 in a calendar year to the lobbyist or the association the lobbyist represents for lobbying purposes.

DISBURSEMENTS (reporting categories)

• Preparing and distributing lobbying materials

The cost of research and writing of reports from which data is subsequently used for lobbying materials is not reportable.

The cost of preparation, publication, and distribution of newsletters or other publications includes pro-rata office expenses and compensation paid to an employee. However, only the cost of that portion of the newsletter or publication which is lobbying material need be reported.

• Media advertising

Only the cost of media including but not limited to billboards, newspapers, radio, and television time which advocate a particular position is reportable.

• Telegraph and telephone

• Postage

• Fees, salaries, and allowances

Includes consultant fees for lobbying purposes as well as expenses incurred in providing those services. Includes compensation for clerical expense incurred for providing lobbying materials or organizing communication with public officials or in urging others to communicate with public officials.

This category does not include compensation paid to a lobbyist for services as a lobbyist on behalf of the employer.

• Entertainment

Includes cost of entertainment provided for a lobbying purpose to public officials as well as the cost of entertainment for the lobbyist, the employer, or employee of the lobbyist when in the company of the public official for whom the lobbyist has paid the cost of the entertainment.

• Food and beverage, travel, and lodging

Includes the cost of food, beverages, travel, and lodging provided by a lobbyist, the employer, or employee of a lobbyist at meetings, banquets, or similar functions for a lobbying purpose.


Includes the cost of food, beverages, travel and lodging provided by a lobbyist, the employer, or employee of a lobbyist at meetings or conferences for the purpose of urging others to communicate with public officials.

Includes the cost of food, beverages, travel, and lodging for paid expert witness if not registered as a lobbyist.

Includes the cost of travel and lodging of a lobbyist for the purpose of lobbying except those incurred to enable the lobbyist to attend a meeting of or to appear before a committee of the legislature, a state board, commission, or agency.

TOTAL DISBURSEMENTS JULY, 1988 THROUGH JUNE, 1989 - \$2,367,022.58


Disbursements by Lobbying Category
