**ETHICAL PRACTICES BOARD ISSUES REPORT ON LOBBYING DISBURSEMENTS**

**FOR JULY, 1993, THROUGH JUNE, 1994**

Lobbying disbursements disclosed by 1,365 lobbyists for 1,161 associations and individuals totaled \$5,689,859 from July 1, 1993, through June 30, 1994, according to reports filed with the Ethical Practices Board.

Lobbyists have filed a total of 8,230 periodic reports for the twelve-month period and disclosed that 847 associations and individuals reported disbursements for lobbying purposes (73% of the associations and individuals for whom lobbyists are registered).

Lobbying disbursements for legislative lobbying in July, 1993, through June, 1994, totaled \$4,743,929 (83% of total lobbying disbursements), compared with \$3,584,797 (61%) July, 1992, through June, 1993, and \$3,965,449 (66%) July, 1991, through June, 1992. Administrative lobbying disbursements in July 1993, through June, 1994, totaled \$801,554 (14% of total lobbying disbursements), compared with \$2,185,570 (37%) July, 1992, through June, 1993, and \$1,857,451 (31%) July, 1991, through June, 1992. Lobbying disbursements seeking to influence the official actions of Metropolitan Governmental Units from July, 1993, through June, 1994, totaled \$144,377 (3% of total lobbying disbursements) compared with \$80,076 (2%) July, 1992, through June, 1993, and \$175,197 (3%) from July 1, 1991, through June 30, 1992.

Minnesota's Ethics in Government Act (Minn. Stat. Ch. 10A) requires lobbyists to report to the Ethical Practices Board disbursements for lobbying purposes including a gift, loan, honorarium, entertainment, food or beverage, travel and lodging equal to \$50 or more given or paid to a public or local official; preparing and distributing lobbying materials, media advertising, telephone and telegraph, postage, fees and allowances, entertainment, food and beverages, travel and lodging. Lobbyists are not required to disclose their salaries or

their political contributions. All lobbyist reports are available for public inspection at the Board office, First Floor South, Centennial Building, 658 Cedar Street, St. Paul.

The Board has prepared a summary of lobbying disbursements for July, 1993, through June, 1994. Included are listings of individuals or associations that contributed over \$500 to associations for lobbying purposes and listings of public or local officials who received gifts, honorariums, or other benefits equal in value to \$50 or more.



### About This Summary

Information in this summary is based on reports filed by lobbyists registered with the Ethical Practices Board. Neither verified nor audited, these reports are available for public inspection at the Board office. No information from filed reports or statements may be sold or utilized by any individual or association for any commercial purpose. Information compiled as of September 20, 1994.

**"Original source of funds"** to associations or individuals represented by a lobbyist - Minn. Stat. Ch. 10A requires that "each original source of funds in excess of \$500 in any year used for the purpose of lobbying shall be reported". List includes the name of the association or individual receiving the funds and the name of the association or individual paying the funds.

**"Disbursements"** to public or local officials - Lobbyists must disclose any gift, loan, honorarium, entertainment, food and beverage, travel, and lodging equal in value to \$50 or more to a public or local official from the lobbyist, the lobbyist's employer, or an employee of the lobbyist; does not include contributions to candidates.

"Public official" means state legislators; constitutional officers of the executive branch and their chief deputies; commissioners, deputy or assistant commissioners of state departments designated in Minn. Stat. §15.01; solicitor general, assistant and special assistant attorneys general; members, chief and deputy chief administrative officers of boards and commissions with rulemaking authority; certain legislative employees; complete list of "public official" designees is available from the Ethical Practices Board office.

. "Local official" means a person who holds elective office in a political subdivision or who is appointed to or employed in a public position in a political subdivision in which the person has the authority to recommend, or to vote on as a member of the governing body, major decisions regarding the expenditure or investment of public money. "Political subdivision" means the Metropolitan Council; a metropolitan agency as defined in Minn. Stat. § 473.121, subd. 5; a municipality as defined in Minn. Stat. § 471.345, subd. 1; the State High School League; and Minnesota Technology, Incorporated.

**"Total disbursements"** by association or individual - This summary includes total disbursements for lobbying purposes by associations or individuals represented by registered lobbyists; "\*" indicates payment of more than \$500 to a lobbyist for lobbying purposes.

#### **Who is a Lobbyist?** \_\_\_\_\_

. Any individual who is engaged for pay or other consideration or who is authorized by another individual, association, political subdivision, or public higher education system to spend money and who spends more than five hours in any month or more than \$250 in any calendar year (not including travel expenses and membership dues) for the purpose of attempting to influence legislative or administrative action or the official action of a metropolitan governmental unit by communicating with or urging others to communicate with public or local officials.

. A nonelected local official or an employee of a political subdivision who spends more than 50 hours in any month attempting to influence legislative or administrative action or the official action of a metropolitan governmental unit, other than the political subdivision employing the official or employee, by communicating with or urging others to communicate with public or local officials, including time spent monitoring any of the forenamed actions and related research, analysis, and compilation and dissemination of information relating to legislative, administrative, or metropolitan governmental unit policies in Minnesota.

. Any individual who spends more than \$250 in any year (not including travel expenses and membership dues) for the purpose of attempting to influence legislative or administrative action or the official action of a metropolitan governmental unit by communicating with or urging others to communicate with public or local officials.

. Any individual who merely communicates with a public official to obtain information or request an interpretation of a law, rule or agency action is not a "lobbyist".

#### **What is Lobbying?** \_\_\_\_\_

Lobbying is defined as attempting to influence legislative or administrative action by communicating with public or local officials or urging others to communicate with public or local officials.

. **"Administrative action"** means an action by any official, board, commission or agency of the state executive branch to adopt, amend, or repeal a rule. "Administrative action" does not include the application or administration of an adopted rule, except in cases of rate setting, power plant and powerline siting, and granting of certificates of need under Minnesota Statutes Chapter 116J.

. **"Legislative action"** means any action or nonaction with regard to any bill, resolution, amendment, nomination, appointment, report, or any other matter which may be the subject of action by either house of the legislature, committee, subcommittee, or commission of the legislature. "Legislative action" also means an attempt to influence a gubernatorial approval or veto of any bill, or an attempt to influence the governor or any public official about development of a proposal for introduction in the legislature.

. **"Metropolitan Governmental Unit action"** means an action to influence the official action of a "metropolitan governmental unit" by communicating with local officials or by urging others to communicate with local officials.

#### **About Lobbyist Registration** \_\_\_\_\_

A lobbyist must complete and file with the Ethical Practices Board a Lobbyist Registration on behalf of each association or individual whom the lobbyist represents. Information disclosed on Lobbyist Registration Form: name and address of the registrant, name of the association (including officers and directors) or individual represented, name and address of lobbyist's principal, and general description of subjects on which registrant expects to lobby and the kind of action the lobbyist seeks to influence.

. "Principal" means an individual or association that spends more than \$500 in the aggregate in any calendar year to engage a lobbyist, compensate a lobbyist, or authorize the expenditure of money by a lobbyist or is not included in the definition above and spends at least \$50,000 in any calendar year in efforts to influence legislative action, administrative action, or the official action of metropolitan governmental units.

All lobbyist registrations and periodic lobbyist disbursement reports filed under the Ethics in Government Act, Minnesota Statutes, Chapter 10A, are available for public inspection at the Board office, First Floor South, Centennial Building, 658 Cedar Street, St. Paul, Minnesota, 55155-1603.

**What must Lobbyists report?** \_\_\_\_\_

Lobbyists are required to file periodic reports with the Ethical Practices Board. For description of "Disbursement Categories", see section C. From July, 1993, through June, 1994, 1,365 lobbyists filed approximately 8,230 reports for 1,161 associations or individuals, disclosing lobbying disbursements of \$5,689,859.

**ABOUT THE ETHICAL PRACTICES BOARD** \_\_\_\_\_

**Purpose**

To maintain public confidence in the integrity of government through public disclosure and public financing of candidates through administration of the Ethics in Government Act, Minn. Stat. Ch. 10A.

**Members**

- . Six-member citizen body;
- . Appointed by the governor to staggered four-year terms; confirmed by 3/5th vote of both houses of the legislature acting separately;
- . One former legislator of each major party;
- . Two individuals who have not been a public official, a holder of or candidate for a party designated office or a political party officer in the last three years before appointment to the Board;
- . No more than three members of the same political party;
- . No lobbyist may be appointed to the Board.

## DISBURSEMENTS: REPORTING CATEGORIES

**Preparing and Distributing Lobbying Materials**-Includes the cost of research and writing, preparation, publication, and distribution of reports, newsletters or other publications for lobbying purposes and pro-rata associated office expenses and compensation.

**Media Advertising**-Includes the cost of media for lobbying purposes, e.g. billboards, newspapers, radio, and television time which advocates a particular position.

**Telegraph and Telephone**-Includes costs associated with lobbying.

**Postage**-Includes costs associated with lobbying.


**Fees, Salaries, and Allowances**-Includes consultant fees for lobbying purposes as well as expenses incurred in providing those services; compensation for clerical expense incurred for providing lobbying materials or organizing communication with public or local officials or in urging others to communicate with public or local officials. This category does not include compensation paid to a lobbyist for services as a lobbyist on behalf of the employer.

**Entertainment**-Includes cost of entertainment provided for a lobbying purpose to public or local officials as well as the cost of entertainment for the lobbyist, the employer, or employee of the lobbyist when in the company of the public or local official.


**Food, Beverage, Travel, and Lodging**-Includes the cost of food, beverages, travel, and lodging provided by a lobbyist, the employer, or employee of a lobbyist at meetings, banquets, or similar functions for a lobbying purpose. Includes the cost of food, beverages, travel, and lodging provided by a lobbyist, the employer, or employee of a lobbyist at meetings or conferences for the purpose of urging others to communicate with public or local officials. Includes the cost of food, beverages, travel, and lodging for a paid expert witness if the witness is not registered as a lobbyist. Includes the cost of travel and lodging of a lobbyist for the purpose of lobbying except those incurred to enable the lobbyist to attend a meeting of or to appear before a committee of the legislature, a state board, commission, or agency.
