

EXECUTIVE SUMMARY

Minnesota's Ethics in Government Act (Minnesota Statutes chapter 10A) requires lobbyists to report disbursements for lobbying purposes to the Campaign Finance & Public Disclosure Board three times a year. Lobbyists are not required to disclose their salaries or their political contributions.

The Board summary of lobbying disbursements for July, 1997, through June, 1998, includes listings of:

- . individuals or associations that contributed over \$500 to associations for lobbying purposes;
- . public or local officials who received gifts, honorariums, or other benefits equal in value to \$5 or more; and
- . total amounts of disbursements made toward lobbying.

Information in this summary is based on reports filed by lobbyists registered with the Board. The information has been neither verified nor audited.

Lobbying disbursement reports submitted by 1,335 lobbyists for 1,221 associations and individuals reported a total of \$6,004,883 spent from July, 1997, through June, 1998.

Lobbyists filed a total of 9,010 periodic reports for the twelve-month period and disclosed that 900 associations and individuals reported making disbursements for lobbying purposes (73% of the associations and individuals for whom lobbyists are registered).

Lobbyists reports are available for public inspection at the Board office. No information from filed reports or statements may be sold or utilized by any individual or association for any commercial purpose.

LOBBYING OVERVIEW

What is lobbying

Lobbying is defined as attempting to influence legislative or administrative action by communicating with public or local officials or urging others to communicate with public or local officials.

Who is a lobbyist

Any individual who is engaged for pay or other consideration or who is authorized by another individual, association, political subdivision, or public higher education system to spend money and who spends more than five hours in any month or more than \$250 in any calendar year (not including travel expenses and membership dues) for the purpose of attempting to influence legislative or administrative action or the official action of a metropolitan governmental unit by communicating with or urging others to communicate with public or local officials.

A nonelected local official or an employee of a political subdivision who spends more than 50 hours in any month attempting to influence legislative or administrative action or the official action of a metropolitan governmental unit, other than the political subdivision employing the official or employee, by communicating with or urging others to communicate with public or local officials, including time spent monitoring any of the forenamed actions and related research, analysis, and compilation and dissemination of information relating to legislative, administrative, or metropolitan governmental unit policies in Minnesota.

Any individual who spends more than \$250 in any year (not including travel expenses and membership dues) for the purpose of attempting to influence legislative or administrative action or the official action of a metropolitan governmental unit by communicating with or urging others to communicate with public or local officials.

Any individual who merely communicates with a public official to obtain information or request an interpretation of a law, rule or agency action is not a "lobbyist".

About lobbyist registration

A lobbyist must complete and file with the Campaign Finance & Public Disclosure Board a Lobbyist Registration on behalf of each association or individual which the lobbyist represents. Information disclosed on Lobbyist Registration Form: name and address of the registrant, name of the association (including officers and directors) or individual represented, name and address of lobbyist's principal, and general description of subjects on which registrant expects to lobby and the kind of action the lobbyist seeks to influence.

Principal

An individual or association that spends more than \$500 in the aggregate in any calendar year to engage a lobbyist, compensate a lobbyist, or authorize the expenditure of money by a lobbyist or is not included in the definition above and spends at least \$50,000 in any calendar year in efforts to influence legislative action, administrative action, or the official action of metropolitan governmental units.

Reports due**Lobbyists**

- January 15th
- April 15th
- July 15th

Principals

- March 15th

Kinds of lobbying**Administrative action**

- Any action by any official, board, commission or agency of the state executive branch to adopt, amend, or repeal a rule. "Administrative action" does not include the application or administration of an adopted rule, except in cases of rate setting, power plant and power line siting, and granting of certificates of need under Minnesota Statutes Chapter 216B.

Legislative action

- Any action with regard to any bill, resolution, amendment, nomination, appointment, report, or any other matter which may be the subject of action by either house of the legislature, committee, subcommittee, or commission of the legislature. "Legislative action" also means an attempt to influence a gubernatorial approval or veto of any bill, or an attempt to influence the governor or any public official about development of a proposal for introduction in the legislature.

Metropolitan Governmental Unit action

- Any activity to influence the official action of a "metropolitan governmental unit".

COMPARISONS OF TOTAL LOBBYING DISBURSEMENTS

Comparisons of total lobbying disbursements broken down by legislative, administrative and metropolitan government unit lobbying shown with the percentage of the total lobbying disbursements for July, 1997- June, 1998; July, 1996 - June, 1997; and July, 1995 - June, 1996 are as follows:

OTHER SOURCES OF FUNDS FOR LOBBYING PURPOSES

Definition

Funds from individuals or associations other than the entity represented of more than \$500 in any year given to the lobbyist, or to any employer or principal of the lobbyist, to be used for purposes of lobbying, including fees or salary paid to a lobbyist as compensation.

Disclosure

The name, address, employer, or if self-employed, the occupation, and principal place of business, of each other individual or other association that paid more than \$500 in a calendar year to be used for lobbying purposes. The actual amount is not required to be disclosed.

REPORTED ITEMS OR BENEFITS TO PUBLIC AND LOCAL OFFICIALS

Definitions

- Public Official

State legislators; constitutional officers and their chief deputies; commissioners, deputy or assistant commissioners of state departments designated in Minn. Stat. §15.01; solicitor general, and assistant attorneys general; members, chief and deputy chief administrative officers of boards and commissions with rule making authority; certain legislative employees; complete list of "public official" designees is available from the Board office.

- Local official

A person who holds elective office in a political subdivision or who is appointed to or employed in a public position in a political subdivision in which the person has the authority to recommend, or to vote on as a member of the governing body, major decisions regarding the expenditure or investment of public money.

- Political subdivision

The Metropolitan Council; a metropolitan agency as defined in Minn. Stat. § 473.121, subd. 5; a municipality as defined in Minn. Stat. § 471.345, subd. 1; the State High School League; and Minnesota Technology, Incorporated.

Disclosure

Any honorarium, gift, loan, item or benefit, including entertainment, food, beverage, travel, and lodging, equal in value to \$5 or more, given or paid to a public or local official from the lobbyist, the lobbyist's employer, or an employee of the lobbyist. This category does not include campaign contributions to candidates.

Reporting categories

- **Preparation and distribution of lobbying materials**

Includes the cost of production, purchase, or other acquisition of materials that directly support lobbying.

- **Media advertising**

Includes the cost of media space or time used for lobbying activities. The cost of preparation of materials for use in the media is reported in the lobbying materials category.

- **Telephone and communications**

Includes costs for local and long-distance telephone services, electronic mail pagers, cellular telephones, facsimile distribution services, telegraph, and other communication services.

- **Postage**

Includes costs of postage from the United States Postal Service as well as other distribution costs associated with lobbying activities.

- **Fees and allowances**

Includes fees for consulting or other services as well as expenses associated with those services. This category does not include compensation paid to a lobbyist for services as a lobbyist on behalf of the employer.

- **Entertainment**

Includes cost of entertainment associated with any situation where lobbying activities take place.

- **Food and beverages**

Includes the cost of all food and beverages associated with any situation where lobbying activities take place.

- **Travel and lodging**

Includes costs of all travel and lodging associated with any lobbying activity, excluding the costs of the lobbyist's own travel to accomplish the lobbying activity.


- **Other disbursements**

Includes general administration and overhead and any other lobbyist disbursements not reported in other categories.

Total lobbying disbursements


- **Lobbying Category by Disbursements**
