**CAMPAIGN FINANCE AND PUBLIC DISCLOSURE BOARD ISSUES FINAL PUBLIC SUBSIDY  
PAYMENTS TO QUALIFYING CANDIDATES IN 2004 ELECTIONS**

The Campaign Finance and Public Disclosure Board paid public subsidy payments totaling \$1,736,164 to eligible state candidates in 2004. Public subsidy payments were made to 267 state House of Representatives candidates.

Public subsidy payments are made from the General Account and the Party Accounts of the State Elections Campaign Fund. Money is allocated to the Fund based on taxpayer checkoffs on state tax returns. The General Account fund is also supplemented by a direct appropriation of \$1,500,000 each general election year. Payments are made to eligible state House of Representatives candidates who were opposed at either the primary or general election. For the 2004 election, 267 state House of Representative candidates received general account payments totaling \$873,510. Each of the 267 eligible state House candidates received a general account payment of \$3,271.

Party account payments totaling \$862,654 were made to 267 state House of Representative candidates in 2004. Party account payments are summarized in the following table:

Payments made from the State Elections Campaign Fund are based on Department of Revenue processing of almost 100% of tax returns. State House of Representatives candidate payments are based on checkoffs from state tax returns for tax years 2002 and 2003.

To be eligible to participate in the public subsidy programs, a candidate must sign and file a Public Subsidy Agreement with the Board in which the candidate agrees to abide by statutory campaign expenditure limits and to limit contributions by the candidate to the candidate's principal campaign committee. A House of Representatives candidate must also raise \$1,500 in individual contributions counting no more than the first \$50 of the contribution and file an affidavit stating that this requirement has been met.

Of the 318 candidates who filed an affidavit of candidacy for the state House of Representatives in July 2004, 311 registered campaign committees with the Campaign Finance and Public Disclosure Board. Of the 311 registered candidates 303, or over 97%, signed Public Subsidy Agreements.
